ORDER DECLARING NOVEMBER 11, 2018 THE VETERANS DAY PARADE FESTIVAL

- **ORDERED,** that Sunday, November 11, 2018 is hereby declared to be the Veterans Day Parade Festival, sponsored by the Harold T. Andrews Post No. 17; and
- **BE IT FURTHER ORDERED,** that the Veterans Day Parade Festival area shall be Congress Street from Longfellow Square to City Hall and the Robert B. Ganley Plaza; and
- **BE IT FURTHER ORDERED**, that on Sunday, November 11, 2018, the parade staging area shall be closed to traffic from 9:00 a.m. to 12:00 p.m. and shall include the following streets:

Congress Street from Mellen Street to State Street; State Street from Cumberland Avenue to Congress Street; Dow Street from Congress Street to Bracket Street; and

BE IT FURTHER ORDERED, that on Sunday, November 11, 2018, the parade route shall be closed to traffic from 10:15 a.m. to 12:00 p.m. and shall include the following streets:

Congress Street from State Street to Pearl Street;

High Street from Spring Street to Deering Street;

Forest Avenue from Cumberland Avenue to Congress Street;

Casco Street from Shepley Street to Congress Street;

Center Street from Free Street to Congress Street;

Preble Street from Cumberland Avenue to Congress Street;

Temple Street from Federal Street to Congress Street;

Chestnut Street from Cumberland Avenue to Congress Street; and

Other streets as the Police Department deems necessary; and

BE IT FURTHER ORDERED, that on Sunday, November 11, 2018, for the ceremony at Robert B. Ganley Plaza the following streets: shall be closed to traffic from 10:30 a.m. to 12:00 p.m.:

Congress Street from Temple Street to Pearl Street; Left-turning traffic from Chestnut Street at Congress Street;

- **BE IT FURTHER ORDERED,** that vehicles in violation of the "no parking" signs in the Festival Area, which shall be posted at the discretion of the parade organizers, shall be towed at owner's expense; and
- **BE IT FURTHER ORDERED,** that the Veterans Day Parade Festival area shall be closed to licensed street vendors as provided in §19-17 of the City Code; and
- **BE IT FURTHER ORDERED,** that the City Manager is authorized to issue a revocable permit to Harold T. Andrews Post No. 17 under §25-27 of the City Code to conduct said Festival, subject to the direction and control of the City Manager and to the following specific conditions:
 - 1. The Harold T. Andrews Post No. 17 shall defend, indemnify and hold harmless the City of Portland, its officers and employees, from and against all claims arising out of or resulting from the Festival and/or use of City streets and property for said Festival, and shall procure and maintain public liability insurance in the minimum amount of \$400,000 per occurrence for personal or bodily injury, death or property damage and covering the obligation of indemnification hereunder. Harold T. Andrews Post No. 17 shall provide the City with a certificate showing evidence of such insurance and showing the City as an additional insured on said insurance:
 - 2. No alcoholic beverages may be sold on the streets or public property during the Festival within the Festival area;
 - 3. Expenses incurred by City Departments for the Veterans Day Parade Festival shall be waived and no permit fees or "No Parking" sign fees shall be charged to the Harold T. Andrews Post No. 17;
 - 4. Conditions for use of the grounds in a permit issued from the Public Assembly Facilities Division Conditions and requirements for food service, vending sales, tent and stage installations and other items specified in that permit shall be adhered to:
 - 5. The Business Licensing Office shall charge the usual fees for licensing food vendors, street goods vendors, and concert licenses for the Festival to those vendors the Harold T. Andrews Post No. 17 has agreed shall participate; and
- **BE IT FURTHER ORDERED,** that the City Manager is authorized to waive fees and to issue such other temporary licenses, including licenses for food service establishments, as may be required by the City Code, provided that all other applicable Code requirements for the operation of the Festival have been met.
